III. Past President's Report: Carla Okouchi

Teacher Evaluation Task Force Update

The Task Force met on October 24, 2011. Carla was seated with Peter Noonan. Carla verbalized to him what she has heard from members regarding the new teacher evaluation process.

FGMEA members are asked to email Carla with any further comments or suggestions about how general music teachers might measure student growth. Carla has received ideas/input from a few members, but she would like more persons to respond.

Some ideas from the Board on how to show student growth: Performance etiquette, videoing students performing, portfolio, rubrics. What is the data showing through these examples?

Comments:

Jeanette: Video tape beginning recorder classes – video after 9 weeks to show progress

Rob: What are General Education teachers using? SOLs? He expressed concern about the 6th grade assessment not being a valid instrument to assess student growth.

Jeanette: There is a mixture of people at the Task Force meetings. Input is equal and diverse. All voices are heard: principals, teachers, and parents.

Fairfax County will tailor the evaluation to meet the needs of teachers/students. The goal is to create a fair and equitable evaluation for all teachers.

The pilot begins in January 2012 for some teachers currently on the Evaluation Cycle.

James Laster: I am concerned about this plan not being a true evaluation. There has to be instructional time included to be a fair evaluation. There may be legal ramifications if we do not proceed with caution.

Carla: A true pilot should be more than 6 months.

Rob: Teachers who are being evaluated this year may be subject to this new evaluation beginning in January 2012.

IV. Secretary's Report: Marian S. Schultz

The September 27, 2011 Board Meeting minutes were approved as corrected.

The minutes were distributed to all general music teachers. Minutes of the remainder of the year's meetings will only be distributed to FGMEA members and posted on the website.

IV. Fine Arts Office Report: Jeanette Essig

Jeanette was happy to see everyone at the October training. She commented that the input given at the training regarding the interior design for music classroom space was helpful to have. Jeanette is working to compile a list of those comments, and will email out the list of ideas that she will share at the meeting with design and construction.

Following the training sessions, several teachers emailed Jeanette with questions regarding the standards based report cards. (Mostly teachers in the field test schools who are actually working in that mode this year.) Those questions are starting a good dialogue.

• For example, a question came up regarding inclusion students which has led to scheduling a meeting next week at which Instructional Services folks in Art, Music and P.E. will meet with Judy Heard and the Special Education office to discuss how to grade low incidence students (those students who may be in a self-contained classroom, but come to specials under the inclusion model).

If a teacher sees a group of children only once a week because of band/strings—and that one time is then interrupted by fire drills, field trips and assemblies, then the teacher might have to indicate "not assessed" on the report card.

Regarding inclusion students, teachers should do their best to meet IEP requirements, with the understanding that the level of daily support for those students varies.....and the assessment should reflect actual practices of a school.

Jacob asked if sixth grade students who are in a middle school setting take the assessment, to which Jeanette replied that they do not.

VIII. Committee Chair Reports

A. In-service: Rob Stansbery for Mary Francis Dini and Vanessa Utell

Mary Francis and Vanessa are very pleased with the outcome of the October 3, 2001 inservice. Based on the surveys that they have received, all scores were 4's and 5's. They are going to wait until the next Board meeting to present further findings to allow for a bit more time for teachers to turn in the surveys.

There are concerns about FGMEA members paying dues for events while non-members attend without paying dues. One idea is to allow access to hand outs only to FGMEA members via the website. Further discussion was tabled until the November meeting.

B. Fall 2012 In-Service

A change has been made to the contract with David Frego, next year's clinician. He wanted to extend the workshop. This change includes an alteration to the time frame with no extra charge. Next year's in-service will be on Monday, October, 1, 2012, from 2:30-5:30 pm. The last hour of the in-service (4:30-5:30) will be a stand-alone session of additional information and instruction.

Jeanette: 5:30 is late and the traffic is heavy at that time of day. She suggested ordering pizza and eating on site so that workshop participants can wait out the traffic.

C. Membership: Debbie Key

Our membership numbers are slightly less than at this point last year. Possible reasons include new teachers who have not joined and retirees who were members and who are no longer members. At this time our dues payments total \$2,305. This compares with \$2,580 at this time last year. Questions were raised regarding the benefits of the online membership process. **Bev** suggested that we wait another year to determine if the online process will make a difference.

D. Choral Festival: Rebecca Caldwell

Rebecca is in the process of inquiring about hotels. It looks to be about \$110 -140 for costs for one night, including a AAA discount.

The read-through session will be held on November 14, 2:30 - 4:30 p.m., at Kings Glen ES. The chairs have been ordered.

All of the site rehearsal schools are arranged. We are in the process of assigning schools to sites. There are some new sites this year.

Emily Sternisha followed up with the information regarding FGMEA acquiring a Costco card for bulk purchases for events such as ACCF, as approved by the Board in September. A business card with 2 names on the card will cost \$55.00 per year. Such an account would provide good savings in bulk for our needs.

• **Rob**: FGMEA is not eligible for a tax exempt card. Virginia tax law requires an organization to be a 501(c)(3) or a 501(c)(4) to be eligible for sales tax exemption. FGMEA is a 501(c)(6) organization.
